## Revised arrangements for the completion of Classroom-Based Assessments

September 2024

### Student cohort 2022 - 2025 (students in 3rd year in 2024/2025)

Students experienced disrupted periods of learning in 2020 and 2021 because of school closures introduced to curtail the Covid 19 pandemic. Despite the best efforts of teachers and schools to mitigate the effects of disrupted schooling, the learning experience of students varied.

**NB: In this context, revised assessment arrangements that were introduced for the year 2023/24 will remain in place for students in third year in the school year 2024/25.**

- Each student must complete a minimum of one CBA in each subject and one CBA in each short course. Students from this cohort will not be required to complete Assessment Tasks.
- Schools have autonomy to decide whether to complete one or two CBAs in each subject.
- There will be some exceptions to the choices made by schools:
  - to ensure assessment of oral communications skills, students must complete **CBA 1: Oral Communication in Modern Foreign Languages** and **CBA 2: Communicative Task in Gaeilge**.
  - as they are linked in each case with the final examination in the subject, students studying **Visual Art, Home Economics, Music, Applied Technology, Engineering, Graphics** and **Wood Technology** must complete CBA 2.
- In Visual Art, one CBA must usually be presented in 3D. This requirement is waived for students in third year in 2024/25.
- In the Physical Education short course, students in third year in 2024/25 are required to complete a minimum of one Classroom-Based Assessment.

Please note that the latest date for completion of CBA1 in all subjects was May 2024 and has now passed.
