#### Themes of Aistear

*Aistear:* the Early Childhood Curriculum Framework presents children's learning and development using four Themes. These are:

- 1. Well-being
- 2. Identity and Belonging
- 3. Communicating
- 4. Exploring and Thinking.

The themes describe what children learn—the dispositions, attitudes and values, skills, knowledge, and understanding. Each theme begins with a short overview of its importance for children as young learners. The theme is then presented using four aims. Each aim is divided into six learning goals. 

• The document is too big for practioners to use as a manual and reference on a daily basis, WCCC would like to recommend an action plan or the aistear/Siolta practice guide for practioners linking it to the DES inspections.



#### **Guidelines for Good Practice**

Aistear has four sets of guidelines, focusing on different aspects of practice:

- 1. Building partnerships between parents and practitioners
- 2. Learning and developing through interactions
- 3. Learning and developing through play
- 4. Supporting learning and development through assessment
